Gentlemen:

My enclosed letter of May 18, 1984, documented the fact that 60 allegations concerning protective coatings had previously been transmitted to Texas Utilities Electric Company personnel at the Comanche Peak Steam Electric Station. Although you have informally provided information to our contractor, Brookhaven National Laboratory, to support their assessment of the safety significance of the allegations, we now request that you respond fully to the issues identified with:

- (1) an evaluation of the validity of each of the specific issues identified, clearly stating the basis for your conclusions,
- (2) the safety significance of each issue in view of your conclusion in item (1), and
- (3) the generic implications on other systems or contractors for any items, singularly or collectively, found to have merit.

Your response should be forwarded to this office no later than June 22, 1984.

The response directed by this letter is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
