

This exercise will be a full-scale ingestion pathway exercise. The State of Wisconsin D.E.G. and both Kewaunee and Manitowoc counties will provide full participation in this exercise. The State of Wisconsin D.E.G. will provide ingestion pathway objectives to FEMA concerning days two and three of the exercise. Wisconsin Public Service Corporation will participate on days two and three in support of the State's objectives. During day two WPSC will activate the Joint Public Information Center fully and establish the Emergency Operation Center as a control cell for State, County and JPIC interaction with utility management. On day three WPSC will send a team to Madison, Wisconsin to participate in round table discussions.

WPSC's Emergency Preparedness staff is prepared to meet with you to discuss the contents of this submittal. Please call Mr. David R. Seebart (414-433-1329), Nuclear Emergency Preparedness Supervisor, to arrange any needed discussion.
