Dear Mr. Fay:

This refers to a reactive inspection conducted by Mr. T. J. Madeda of this office between May 21 and June 10, 1991, of activities at the Point Beach Nuclear Power Plant authorized by NRC Operating Licenses No. DPR-24 and No. DPR-27 and to the discussion of our findings with Mr. G. Maxfield and other members of your staff on June 10, 1991.

The enclosed copy of our inspection report identifies the areas examined during this inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel. Our review involved an evaluation of specific concerns relating to your security training program, implementation of compensatory measures, and some management actions relating to your security organization.

During this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice. A written response is required. The violation, which contains Safeguards Information, is discussed in the Attachment to this report.

The NRC is also concerned that a recent job action involving former contractor security employees may have a chilling effect on current contractor security personnel. Wc are concerned that security personnel might be deterred from identifying and reporting security related concerns they may have. Therefore, you are requested to provide this office, within 30 days of the date of this letter, a response which describes your actions, if any, taken or planned to assure that the previous employment action does not have a chilling effect in discouraging other contractor security employees from raising security and safety concerns in the future. The chilling effect is discussed in concern 4.d of this report.
