Technical Specification (TS) 3.4.6.2, "Reactor Coolant System Leakage," had been entered at 8:00 a.m. due to increasing containment activity readings and increased containment sump leakage. The leak rate was later calculated to be about 5 gpm. Entry into the containment identified a steam leak in the area of the upper root valves for pressurizer level indicators. The leak could not be confirmed as a packing leak and was classified as unidentified at about 11:40 a.m. An Unusual Event was not declared since the shutdown was being conducted in accordance with the TS action statement. A one-hour non-emergency report was made to the NRC a approximately 11:58 a.m. The resident inspectors monitored the implementation of the RCS leak abnormal procedure and the reactor shutdown. The facility will immediately enter its first refueling outage, which was scheduled to begin on July 27. The State of New Hampshire and the Commonwealth of Massachusetts were notified.
