SUBJECT: DOCKET NOS. 50-321 AND 50-366

This acknowledges the receipt of your letter of February 24, 1992, which transmitted Revision dated December 1991 to the Hatch Physical Security Plan.

Our review of the changes has found portions of the changes to be consistent with the provisions of 10 CFR 50.54(p) and are acceptable for inclusion in the Physical Security Plan. One portion requires clarification in order for this change to be reviewed under this provision. Section 12.1 of the Physical Security Plan must be revised to delineate that all elements of Regulatory Guide 5.66 have been implemented or the program contained in this Regulatory Guide must be incorporated in total into your Physical Security Plan. You are also required to include a letter or statement in your submittal letter certifying that this has been accomplished. This was discussed between Mr. David Edge of your staff and Ms. Orysia Masnyk of the NRC during a telephone call on March 11, 1992.

The enclosure to your letter is being withheld from public disclosure because it contains Safeguards Information and must be protected in accordance with the provisions of 10 CFR Part 73.21.

Should you have any questions concerning this letter, we will be glad to discuss them with you.
