Subject: Combined Inspection Report Nos. 50-352/92-03 and 50-353/92-03

This letter transmip the results of the resident safety inspection by Mesers. T. Kenny and L. Scholl, from January 5, 1992 - February 15, 1992, at the Limerick Geographic Station, Limerick, Pennsylvania. The inspection focused on the observation of activities important to ensuring the public health and safety. Reviews of documents and interviews of plant personnel were also performed. The results have been discussed with Mr. J. Doering of your staff.

During a review of recurring failures of a motor operated valve in the Residual Heat Removal System, the inspectors found problems with the planning, execution and oversight of the valve maintenance activities. Also, maintenance procedures were not followed. This violates NRC requirements, as specified in the enclosed Notice of Violation (Notice). We noted that when these maintenance issues were brought to your attention, you temporarily stopped work until maintenance packages were reviewed by mid-level management. Because the problems appear to be recurrences of previous similar issues, we believe this area needs continuing management attention to ensure maintenance activities are properly planned and executed.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room. The responses directed by this letter and the enclosed Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub.
