Between March 13 and April 10, 1984, Messrs. R. Conte and F. Young conducted a routine safety inspection of activities authorized by NRC License No. DPR-50 at your facility. The attached NRC Region I Inspection Report described the areas examined. Within these areas the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector. At the conclusion of the inspection, Mr. Conte summarized the inspection findings to Mr. R. Barley and other members of your staff as noted in the inspection report. Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter.
