Gentlemen:

The following applications were filed with the Office of Nuclear Reactor Regulation (ONRR) for review in connection with the Joseph M. Farley Nuclear Plant Unit Nos. 1 and 2:

1. Two January 28, 1983 requests for relief from certain inservice inspection requirements (one request applied to Unit 1 and the other to Unit 2). A Class III fee (\$4,000) was paid for the Unit No. 2 request and a Class I fee (\$400) was remitted for Unit No. 1 pursuant to 10 CFR 170.22.
2. A July 5, 1983 application, as supplemented by letter dated September 27, 1983, for relief from certain inservice testing requirements for pump and valves for Unit Nos. 1 and 2. Classes III and I fees totalling \$4,400 were remitted with your September 27 filing.

Based on information provided by the ONRR staff as the result of their final review of these requests, it has been determined that two Class III fees (\$8,000) are appropriate for each of the above items 1 and 2 since in each instance the reviews involved consideration of separate safety issues for each unit. The requests were not identical for each unit; therefore, they are not considered to be duplicative in nature. The applications referred to in item 1 were approved by letters and Safety Evaluations dated September 22, 1983 for Unit No. 2 and February 10, 1984 for Unit No. 1. The item 2 application was approved by letters and Safety Evaluations dated September 16, 1983 for Unit No. 2 and January 26, 1984 for Unit No. 1. For each of the above two items, an additional sum of \$3,600 is due.

In summary, you are requested to remit a total of \$7,200 to this office to complete the fees due for the above applications.
