This refers to the inspection conducted by W. Tubin of this office on March 8-12, 1992. The inspection included a review of activities authorized for your Vogtle Electric Generating Plant. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The enclosed Inspection Report identifies activities that appear to violate NRC requirements that are not cited; therefore, a response is not required. These requirements are relative to the security of vital area portals and the adequancy of your 1991 Safety Audit and Engineering Review of the Vogtle Security Program. Your corrective actions to these two issues will be reviewed in future inspections. Additionally, an Unresolved Item relative to the ammunition issued to the Vogtle Security Force is being reviewed at NRC Headquarters.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR Part 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material will not be placed in the Public Document Room.
