This acknowledges the receipt of your letter of February 28, 1992, which transmitted Revision 27 to the Surry Physical Security Plan.

Our review of the changes has found them to be consistent with the provisions of 10 CFR 50.54(p). Accordingly, they are acceptable for inclusion into the plan.

As discussed in a teleconference on March 30, 1992 between Ms. O. Masnyk of this office and Mr. D. Jenkins of Virginia Power several issues require clarification. Section 1.5.1 needs clarification that Security General Employee Training is accomplished annually. Section 2.5 dealing with lock and key rotation, Sections 9.4.1, 9.4.2, and 9.2 dealing with records, and Section 4.4.1 dealing with the alarm stations need the original details reincorporated back into this revision. Section 3.2 should be clarified to read that all elements of Regulatory Guide 5.66 have been implemented. Section 4.3.3 dealing with balanced magnetic switches must have the applicable portion of Interim Federal Specification W-A-00450-B replaced. Section 7.3 needs language that indicates that security will not be diminished during construction activities. Sections 2.2.6(c) and 4.3.1 have to have the relationship between the alarms discussed in this area and the alarm stations clarified.

The enclosure to your letter is being withheld from public disclosure because it contains Safeguards Information and must be protected in accordance with the provisions of 10 CFR Part 73.21.
