SUBJECT: NRC INSPECTION REPORT NOS. 50-335 AND 50-389

This acknowledges the receipt of your letter of March 10, 1992, which transmitted Revision 32 to the St. Lucie Physical Security Plans.

Most of the changes are found to be consistent with the provisions of 10 CFR (50.54(p)). Accordingly, they are acceptable for inclusion into the plan.

In order for Section 1.3.1 discussing the screening program to be reviewed by the Region under the provisions of 10 CFR 50.54(p), it must be worded to indicate that all elements of Regulatory Guide 5.66 have been implemented. Please resubmit this section to reflect this clarification or submit this portion to the Office of Nuclear Reactor Regulation in NRC Headquarters for review. This was discussed in a teleconference on March 31, 1992, between Ms. O. Masynk of this office and Mr. W. White of Florida Power and Light Company.

The enclosure to your letter is being withheld from public disclosure because it contains Safeguards Information and must be protected in accordance with the provisions of 10 CFR Part 73.21.

Should you have any questions concerning this letter, we will be glad to discuss them with you.
