These complete our commitments for surveying Union Electric lands at Callaway. We are continuing in our efforts to resolve the status of three potentially significant sites falling within the plant's operation and maintenance zones. These three sites will be nominated to the National Register of Historic Places (NRHP) and will be investigated, if necessary, using Phase II survey techniques to determine NRHP eligibility. The requirements for this nomination procedure will be outlined in the Environmental Protection Plan (EPP), Appendix B of the Callaway Operating License.
