Gaseous Activity for Purge and Exhaust Isolation Revised Technical Specification Change Request

Centlemen:

On February 20, 1991, Entergy Operations requested a change (2CAN#291#3) to the ANO-2 Technical Specifications revising Table 3.3-6 and 4.3-3 to require the process monitor for gaseous activity for purge and exhaust isolation be operable when the monitor is actually in use rather than during all Modes.

Based on a conversation with the ANO-2 NRR Project Manager, Entergy Operations is submitting a proposed revision to the previous request. The revision changes our proposed Applicability from "During purge or when ventilating during Mode 6 Core Alterations" to "Modes 5 and 6". Additionally, Action 16, which currently reads "With the number of channels OPERABLE less than required by the Minimum Channels OPERABLE requirements, comply with the ACTION requirements of Specification 3.9.9" is to be replaced. Specification 3.9.9 requires suspension of all operations involving movement of fuel assemblies or CEAs within the pressure vessel. The proposed Action 16 requires securing the purge system during fuel movement and containment purge operations and provides ACTIONS for continuous ventilation with an inoperable monitor.

Additionally, a change is being made to the Bases for this Specification to distinguish between a purge and continuous ventilation and to provide clarification of required actions. As this involves no intent change to our previous submittal, the no significant hazards consideration from our previous submittal is still applicable.
