SUBJECT: HARRIS: REQUEST FOR INQUIRY - FALSIFICATION OF HYDROTESTS
(REF. CASE 2G067)

In a letter to SECY commenting on a proposed rule change an individual alleged that he had been told (by an unnamed source) that pipes had been welded closed internally to make pressure tests appear to be satisfactory. If true, this would represent a falsification of test data which may or may not be required by the NRC.

Region II requests that you conduct an inquiry into this matter including contact with the alleged and his source of information to obtain more specific information. Depending on the results of your inquiry, we may request an investigation.
