This refers to the inspection of your radiation protection program conducted by Mr. J. Furia of this office on October 28 - November 1, 1991, and to the discussion of our findings held by Mr. J. Furia with Mr. P. Katz and other members of your staff at the conclusion of the inspection.

The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector and included a review of the implementation of the radiation protection program during the Unit 2 mid-cycle outage.
