As requested by the March 31, 1992 letter from Donald Irwin of Hunton & Williams on behalf of Kansas Gas and Electric Company and as discussed with Steve Wideman of your staff on March 31, 1992, the NRC considers your March 20, 1992 request to amend Facility Operating License NPF-42 to be withdrawn. The proposed amendment requested an extension of the allowed date for the merger of Kansas Gas and Electric Company and Kansas Power and Light Company from March 31, 1992 until May 31, 1992. The need for the amendment was negated when the merger was completed on March 31, 1992. Unless instructed otherwise prior to April 17, 1992, the NRC will publish a Notice of Withdrawal in the Federal Register and close out TAC No. M82981.
