In accordance with Section G.5, Task Order Procedures, of the subject contract, this letter definitizes Modification No. 1 to Task Order No. 140 which increases the task order ceiling amount obligated amounts by \$3,449.00 from \$45,647.00 to \$49,096.00, and incorporates the participation in on-site pre-examination preparation.
