Subject: Contract No. NRC-26-92-267, Modification No. 1 to Task Order No. 2

The purpose of this modification is to: (1) increase the level of effort and (2) increase the task ordering ceiling and the obligated amount by \$4,623.00 from \$95,353.00 to \$99,976.00. Accordingly, the subject task order is modified as follows:

The third and fourth paragraphs of the definitization letter are deleted in their entirety and substituted with the following in lieu thereof:

"Task Order No. 2 shall be in effect from July 25, 1993 through November 25, 1993 with a total cost ceiling of \$99,976.00. The amount of represents the total estimated reimbursable costs and the amount of represents the fixed fee.


