Subject: Modification 1 to Task Order 220, Contract No. NRC-03-89-031

The purpose of this modification is to reduce the level of effort from three to two certified Westinghouse examiners to assist Region II in the administration of operator licensing examination at the Turkey Point Nuclear Power Plant.

In accordance with Section G.5, Task Order Procedures, of the subject contract, this letter definitizes Task Order No. 220, Modification 1. As a result of the decrease in the level of effort, the total cost ceiling of this task order is reduced by \$18,899.00 from \$92,108.00 to \$73,209.00.

Task Order No. 220, Modification 1, shall be in effect from the date of this letter through March 28, 1994, with a cost ceiling of \$73,209.00.
