The referenced document states that "OPOPO4-HE-0001, "Loss of EAB or Control Room HVAC", will be revised by December 31, 1991, to include provisions for opening relay room cabinet doors in the event of a SBO" (Station Blackout). If a Station Blackout occurs, OPOPO4-AE-0001, "Loss of any 13.8 or 4.16 kV Bus", will be used to respond to the loss of power. Therefore the provisions for opening relay room cabinet doors should be placed in OPOPO4-AE-0001, "Loss of any 13.8 or 4.16 kV Bus" instead of OPOPO4-HE-0001, "Loss of EAB or Control Room HVAC". It is requested that the commitment made in the referenced document be changed to the following:

OPOPO4-AE-0001, "Loss of any 13.8 or 4.16 kV Bus" will be revised by December 31, 1991 to include provisions for opening relay room cabinet doors in the event of a Station Blackout".
