Dear Jane and Mike:

At our meeting in Chicago last Thursday, May 25, 1984, Jane asked that the Staff provide a list of all personnel who have been involved in the Byron reinspection program and a description of their involvement. I agreed to assemble and provide that information without the need for formal discovery.

The following information responds to Jane's request. There may be changes to this list as additional information is gathered; if so, I will provide any such changes promptly. With respect to the third column below, an individual is considered to have a role in the development of the reinspection program if: they helped formulate the NRC position; they provided comments or suggestions on proposed positions; or they reviewed and concurred in all or any part of the program. An individual is considered to have a role in the evaluation of the reinspection program if: they reviewed inspection results for technical adequacy, completeness and/or understandability; or they reviewed in whole or part drafts, interim or final reports of program results for technical content, accuracy, completeness and/or compliance to program requirements or commitments. An individual is considered to have a role in the implementation of the reinspection program if they conducted inspection to gather facts or to verify any part of the program requirements or commitments.


