This refers to your license amendment request dated February 26, 2020. Please find enclosed Amendment No. 7 removing Carlos Montalván-Miró, M.D. as Radiation Safety Officer and naming David Rhoe as Radiation Safety Officer.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
