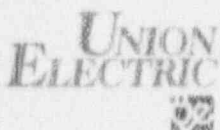

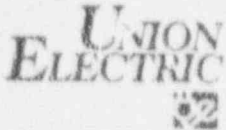

Furnished herewith for your review and approval is a copy of Change Notice 90-10 to the Callaway Plant Operating Quality Assurance Manual (OQAM) consisting of the following:

1. OQAM (Change Notice 90-10) mark-up, identifying changes through the use of inserts and strikeovers.
2. Explanations and justifications for changes to the OQAM.

The proposed revisions provide for the processing of QA originated corrective action documents consistent with all similar documents. Specifically, in-line QA approval of responses and verification of actions to correct deficiencies has been deleted; in addition, Section 16 has been rewritten to simplify preparation of corrective action procedures.

Pursuant to the requirements of 10CFR50.54(a)(3), the changes have been evaluated by Union Electric. The change involving deletion of in-line QA review of the above noted documents is considered to be a lessening of commitment, and requires your approval prior to implementation. The revised OQAM continues to satisfy the requirements of 10CFR50, Appendix B.
