ORDER PERMITTING PHILADELPHIA TO REPLY TO ANSWERS
TO ITS OFFSITE EP ISSUES

As requested by the City of Philadelphia, if it desires it may reply to the answers to its proposed offsite emergency planning issues. Any reply filed by the City will be most helpful if it is concise and specific in its disagreement with points raised by the opposing answers in the context of what the City sees as the gravamen of its issue.

Any reply filed by the City shall be received by the Board and the participating parties by June 13, 1984. The Board will announce during the hearing, which will be held the week of June 19, 1984, whether oral argument will be held on the admissibility of the City's issues. If oral argument is deemed useful by the Board, it will likely be scheduled for June 21 or 22.


