Dear Ms. Garde:

This is in further response to your letter dated March 15, 1984, in which you requested, pursuant to the Freedom of Information Act, all documents concerning four items.

The documents listed on Appendix A are being placed in the Public Document Room (PDR), 1717 H Street, NW, Washington, DC.

The names and title of positions of confidential sources have been deleted from the last page of IE 50-483/78-04 pursuant to exemption (7)(D) of the Freedom of Information Act (5 U.S.C. 552(b)(7)(D)) and 10 CFR 9.5(a)(7)(iv) of the Commission's regulations in order to protect their identities. The nonexempt portions of this report are being placed in the PDR.

This office has been informed by Region III that no documents relating to Mr. Foster's verification of Individual B's previous experience could be located in either the Region's files or in Mr. Foster's files, and that no written statement was executed by Individual D.

Pursuant to 10 CFR 9.9 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The persons responsible for this denial are the undersigned and Mr. James Keppler, Regional Administrator, Region III.


