SUBJECT: NRC GENERIC LETTER 89-10 INSPECTION AT V. C. SUMMER NUCLEAR STATION
DURING THE WEEK OF JANUARY 27-31, 1992

This letter is to confirm the above dates for a Nuclear Regulatory Commission inspection at your V. C. Summer Nuclear Station. The inspection will examine the program you have developed in response to Generic Letter 89-10, "Safety-Related Motor-Operated Valve Testing and Surveillance." The dates were agreed to during telephone conversations between Al Koon of your Licensing staff and F. Jape of this office.

As discussed on January 6, 1992, it is our understanding that you will forward us the following information to aid in preparing for the inspection:

1. The procedure or other documents that describe your MOV program.
2. A list of the valves in the program (if not already included in the program description requested in 1 above).
3. A list of the valves for which you have completed the design basis reviews.
4. A list of the valves that have been diagnostically tested to verify their capabilities in accordance with the program.
