Gentlemen:

This letter is to reconfirm and update the NRC Region III Access Authorization Lists for admitting NRC personnel to your facilities.

The NRC inspectors, identified by the Regional Administrator as delegated to the Chief, Materials and Safeguards Branch, Region III, in Enclosure 1 are likely to visit your facilities, on an announced or unannounced basis at any time, day or night, and are required to be provided permanent non-employee, no-escort required picture badges as authorized by 10 CFR 73.55(d)(5). Other NRC Region III personnel, not accompanied by an individual indicated in either Enclosure 1 or 2 should be provided access in accordance with your access control procedures or after telephonic verification of authorization has been effected with the Region III Duty Officer or Safeguards Section.
