As discussed on June 19, 1991, between D. Verrelli of my staff and W. G. Hairston of Alabama Power Company, this letter is in reference to information received by the NRC. The details of this information are included in the enclosure to this letter.

The enclosed information is provided for your review so that you can take appropriate action. You are requested to provide your findings to us within 45 days of receipt of this letter. If this information is substantiated, your response should include any proposed corrective actions you believe are appropriate. In addition, your review should be conducted by a group sufficiently independent from the activities in question.

Appropriate safeguards should be applied to the enclosed information in view of its unsubstantiated nature. The enclosure to this letter is being withheld from public dissemination in accordance with the provisions of 10 CFR 2.790. If your response contains any privacy or privileged information that you believe should be withheld from public disclosure, please provide that information in an appropriately marked enclosure to your response letter. In addition, if you provide any information which you believe is proprietary, please provide the affidavit required by 10 CFR 2.790. In order to ensure appropriate protection for the information, please indicate on the envelope that it is "TO BE OPENED BY ADDRESSEE ONLY."
