This refers to the routine safety inspection conducted by Mr. R. P. Zimmerman, Mr. W. A. Cook, and Mr. W. J. Lazarus of this office on March 1, 1984 through April 20, 1984 at the R. E. Ginna Nuclear Power plant of activities authorized by NRC License No. DPR-18 and to the discussions of our findings by Mr. Cook with Mr. Mr. B. Snow and other members of your staff periodically during the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures, and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.




