This letter transmits the report of the routine resident safety inspection conducted by Mr. D. Vito for the period November 10, 1991, through December 14, 1991, at the Oyster Creek Nuclear Generating Station. The inspection consisted of document reviews, personnel interviews and observations of activities. Inspectors discussed the findings with you and members of your staff after the inspection.

Please note our concerns regarding the control of measuring and test equipment. As a result of this inspection, certain activities associated with the traceability of maintenance and test equipment appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response.


