Gentlemen:

The purpose of this letter is to notify the NRC of Beaver Valley Power Station Unit 2 (BVPS-2) revised schedule for the completion to the rework being done on the three cold leg steam generator (S/G) nozzles as a result of NRC's Notice of Violation cited in Inspection No. 50-412/83-01, Reference (a). BVPS-2 committed in Reference (b) to have the rework for the three cold leg S/G nozzles completed and ready for final acceptance by July 31, 1984. This rework is in process; however, it is now expected that the grinding phase of the rework will be completed by May 31, 1984. If any weld repair is required then this work will be completed by October 31, 1984.

The NRC Resident Inspector has been informed of this revised schedule.
