Description of Deficiency

Incorrect wiring connections have been identified on isolator cabinets manufactured for TVA for Bellefonte Nuclear Plant by E-Max Instruments, Incorporated, Englewood, Colorado. The isolators provide physical separation and electrical isolation between class 1E and non-class 1E circuits.

This NCR was determined to be significant based upon the repetitive NCRs which have been written against Balance-of-Plant (BOP) Isolator Cabinets supplied by E-Max, Inc. Information available at the site indicates that the cabinets were not source inspected by TVA.

Interim Progress

TVA has removed and reconnected, per vendor drawings, all wires found to be incorrectly connected. TVA has also determined that this deficiency does not apply to any other TVA nuclear plant, and has not occurred for Bellefonte on any subsequent contracts with E-Max. TVA is still investigating this item to determine the assignable cause.
