ATTACHMENT 1

The following discussion is submitted in support of an amendment request to Technical Specification 3.4.6.2.

- Ttem 1 Union Electric will commit to the leakage trending provisions of ASME Section XI Subsection IWV-3427(b), Summer 1980, Winter 1981 Addendum. In addition, the Callaway Pump and Valve Program with respect to Relief Request #V05 will be revised to reflect this change, as appropriate.
- Item 2 Union Electric is revising proposed Technical Specification 3.4.6.2.f to limit leakage for valves which are 2 inch or smaller to 0.5 gpm per nominal inch of valve size. This change subjects all the valves addressed in this specification to the same requirements. Revised Technical Specification pages which reflect this change are attached.
