Florida Power Corporation (FPC) hereby submits Technical Specification Change Request No. 173, Revision 1 requesting amendment to Appendix A of Operating License DPR-72. As part of this request the following information is provided; (1) the proposed replacement pages for Appendix A, (2) a summary of changes for TSCRN 173, Rev. 1, (3) a draft Offsite Dose Calculation Manual, and (4) draft pages for the Process Control Program.

This submittal proposes the deletion of the Radiological Effluent Technical Specifications requirements from the Technical Specifications. This is proposed in accordance with the guidance provided in Generic Letter 89-01, "Implementation of Programmatic Controls for Radiological Effluent Technical Specifications in the Administrative Controls Section of the Technical Specifications and Relocation of Procedural Details of RETS to the Offsite Dose Calculation Manual or to the Process Control Program". Attachment 2 provides a comparison of proposed changes to the guidance provided in Generic Letter 89-01.
