By letters dated July 1, 1992, October 29, 1993, and June 3, 1994, Entergy Operations, Inc. provided its response to Generic Letter (GL) 92-01, Revision 1. By letter dated June 23, 1994, the Babcock & Wilcox Owners Group (B&WOG) submitted for staff review plant specific information in BAW-2222 confirming the applicability of topical reports, BAW-2178PA and BAW-2192PA, which related to the equivalent margin analysis as required by Appendix G to 10 CFR Part 50. By letter dated July 8, 1994, Entergy Operations, Inc. proposed changes to the NRC reactor vessel data base for ANO-1 and confirmed that BAW-2178-PA and BAW-2192PA, as well as BAW-2222 are applicable to ANO-1.

The NRC staff has completed review of the submittals referenced above and summarized the evaluation of these documents in the enclosed Safety Evaluation. Our evaluation concludes that the ANO-1 response to GL 92-01 is complete. This completes work tracked by our TAC No. M90741.
