SUBJECT: MODIFICATION NO. 1 TO TASK ORDER NO. 7 ENTITLED "CANDU 3U SHUTDOWN SYSTEMS RELIABILITY ANALYSIS" UNDER

CONTRACT NO. NRC-03-93-032

NRC's effort on the subject task order is no longer required by the applicant, AECL Technologies, effective March 31, 1995. Therefore, the purpose of this modification is to revise the period of performance, thereby decreasing the estimated level of effort by 572.2 hours from 1,379 hours to 806.8 hours. In addition, the task order ceiling and obligated amounts are decreased by \$53,930.92 from \$128,562.00 to \$74,631.08. As a result of the decrease in the level of effort, the enclosed Statement of Work identifies the work performed under this task order.

In accordance with Section G.5(c) of the subject contract entitled "Task Order Award," this letter definitizes Modification No. 1 of the subject task order.

The third paragraph of the definitization letter of the basic task order is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 7 shall be in effect from December 23, 294 through April 30, 1995, with a cost ceiling of \$74,631.08. The amount of represents the total reimbursable costs, the amount of \$5,830.88 represents the fixed fee, and the amount of represents the facility's capital cost of money."
