In Reference (1), the NRC Staff provided specific information on "Apparently Fraudulent Products, Sold by Ray Miller, Inc." The information included a fraud data base file as an attachment. Licensees and Applicants were requested to determine where suspect material has been installed in plants, evaluate its safety significance, and tag or dispose of the suspect material not yet installed.

Reference (2) provided a list of end users of the Ray Miller, Inc. materials and a list of companies who provided Ray Miller, Inc. materials to others. Reference (3) further supplemented information contained in Reference (2).

The architect-engineer for Millstone Unit No. 3, Stone & Webster Engineering Corporation, has completed a comprehensive investigation to determine the applicability of References (1), (2), and (3) to Millstone Unit No. 3. We have no record of receipt or installation of materials from Ray Miller, Inc. for Millstone Unit No. 3.
