This refers to the special safety inspection conducted by Mr. R. Nimitz of this office on March 14-15 and 20-21, 1984 of activities authorized by NRC License Nos. NPF-14 and CPPR-102 and to the discussions of our findings held by Mr. Nimitz with Mr. H. Keiser of your staff at the conclusion of the inspection. Additionally the circumstances surrounding a number of radioactive spills at the site were discussed in a meeting between Messrs. Nimitz, McCabe and Shanbaky of this office with Mr. Keiser. Corrective actions dealing with these spills were also discussed.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. The inspection of your radiological safety program consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). 


