This is in response to Boston Edison Company's letters dated October 31, 1983, and January 30, 1984, regarding Revision Nos. 13 and 14 to the Pilgrim Station Modified Amended Security Plan and Revision No. 3 to the Pilgrim Station Safeguards Contingency Plan.

We have reviewed the information contained in these plan revisions and have determined that portions of the revisions are consistent with the provisions of 10 CFR 50.54(p), and are considered acceptable.

However, certain other portions of the revisions are not considered acceptable for the reasons stated in the enclosure to this letter. For these portions, you are to modify your plan to accommodate the attached comments. Corrected page revisions should be submitted to this office within 30 days of the receipt of this letter.

The enclosure to your above referenced letter and the enclosure to this letter are being withheld from public disclosure since they contain Safeguards Information and must be protected in accordance with provisions of 10 CFR 73.21.
