The U.S. Nuclear Regulatory Commission (Commission) has issued Amendment Nos. 209 and 213 to Facility Operating Licenses Nos. DPR-44 and DPR-56 issued *o PECO Energy Company (the licensee), which revised the Technical Specifications for operation of the Peach Bottom Atomic Power Station, Units 2 and 3, located in York County, Pennsylvania. The amendment is effective as of the date of issuance.

The emendment modified the Technical Specifications to provide for an increased allowed out-of-service time for the Peach Bottom emergency diesel generators based on the availability of a power tie-line from the Conowingo Hydroelectric Station.

The application for the amendment complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations. The Commission has made appropriate findings as required by the Act and the Commission's rules and regulations in 10 CFR Chapter I, which are set forth in the license amendment.

Notice of Consideration of Issuance of Amendment to Facility Operating License and Opportunity for a Hearing in connection with this action was published in the FEDERAL REGISTER on June 7, 1995 (60 FR 30120). No request for a hearing or petition for leave to intervene was filed following this notice.
