

MRO SIX MONTH REPORT

From January 1, 1995 through June 30, 1995, our records indicate no confirmed positives in any of the program categories for the licensee or long-term contractor pools. There were three confirmed positives recorded in the short-term contractor pool. All three individuals were denied unescorted access and returned to the contractor/vendor for further disposition.

Follow-up to Previous MRO Reports

As previously reported, in the Performance Report of June 30, 1994 through December 31, 1994, one licensee employee experienced a confirmed positive in the for-cause/observed behavior program. The employee was denied unescorted access, evaluated by the EAP provider, and completed an intensive out-patient rehabilitation program on December 30, 1994. On January 3, 1995, the employee was returned to work and placed in the follow-up program. On June 1, 1995, the employee elected retirement. Unescorted access was never reinstated.
