SUBJECT: REPORT NOS. 50-259/83-51, 50-260/83-51 AND 50-296/83-51

This refers to the special safeguards inspection conducted by Mr. A. Tillman of this office on November 14-18, 1983, of activities authorized by NRC License Nos. DPR-33, DPR-52, and DPR-68 at Browns Ferry facility and to the discussion of our findings held with Mr. J. E. Swindell, Assistant Plant Superintendent, at the conclusion of the inspection.

Areas examined during this inspection included your Physical Security program under the applicable provisions of Title 10, Code of Federal Regulations, Part 73, "Physical Protection of Plants and Materials" and the specific requirements of your approved Security Plan. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, performance tests, and observations by the inspector.

The enforcement action related to this inspection was addressed to you in a letter dated March 7, 1984, from Mr. James P. O'Reilly, Regional Administrator.

With regard to the reportability of the event identified as an unresolved item in paragraphs 2 and 3, Region II and NRC Office of Inspection and Enforcement have concluded that the matter did not constitute a violation of regulatory requirements.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material, with the exception of the report cover page which is an inspection summary, will not be placed in the Public Document Room.
