

## Summary of Data Analysis and Management Actions Peach Bottom Atomic Power Station January - June 1995

#### Initiatives Taken

L

The following summarizes the results of sweeps conducted by PECO Energy Company's drug sniffing canine teams as well as investigations and interviews used to confirm information about illicit activities at Peach Bottom Atomic Power Station (PBAPS) during the period.

- a. January 31, 1995 General team sweep of the Document Control Section. Results: Four activations. No drugs found or forensic samples taken.
- February 28, 1995 General team sweep of the South Substation Control House. Results: No activations.
- c. March 14, 1995 For cause team sweep of an employee's private vehicle. Results: No activations. However, an open alcohol beverage container was discovered in plain view. Employee tested positive for alcohol. <u>Plant access denied</u>.
- d. March 31, 1995 General team sweep of the North Substation. Results: Four activations. No drugs found or forensic samples taken. An opened container of vodka was found in a Company vehicle. Employee admitted to purchasing the vodka. Employee disciplined and plant access denied.
- e. March 31, 1995 General team sweep of the Plant Services Building, first floor. Results: Two activations. No drugs found or forensic samples taken.
- f. May 4, 1995 General team sweep of Laydown Area between "C" and "D" cooling towers. Results: Two activations. No drugs found or forensic samples taken.
- g. May 22, 1995 For cause team sweep of a Company vehicle and employee's possessions. Results: Three activations. No drugs found or forensic samples taken.
- May 25, 1995 For cause team sweep of employee's possessions and private vehicle.
  Results: Four activations. Employee denied illegal drug use, but tested positive for marijuana. <u>Plant access denied</u>.
- May 26, 1995 General team sweep of five different owner controlled areas and one Company vehicle. Results: No activations.
- June 16, 1995 General team sweep of one contractor vehicle and twelve Company vehicles. Results: Four activations. No drugs found or forensic samples taken.

#### II. Management Actions

During the period, three PECO Energy employees (i.e., one random, two observed behavior) tested positive at PBAPS. Unescorted access was denied for all three employees. The employees were provided treatment and rehabilitation through the PECO Energy Employee Assistance Program. One employee has subsequently been granted unescorted access. The other two employees have been assigned to duties which do not require unescorted access.

## III. Events Reported Under 10 CFR 26.73

There were no significant FFD events reported by PBAPS during the period.

#### IV. Audits/Inspections

During the period, the NRC Region I conducted a reactive FFD inspection (Inspection Report Nos. 50-352/95-08 and 50-353/95-08). The inspection was primarily conducted at Limerick Generating Station (LGS), but examined aspects of the program across the Nuclear Group. A summary of the inspection findings is reported under Attachment 2, "Summary of Data Analysis and Management Action, Limerick Generating Station."

## V. Random Testing Rate

PECO Energy maintains separate testing "pools" for employees and contractors. Random testing is conducted at an annualized rate of 50%. The "average number with unescorted access" includes personnel granted unescorted access at both PBAPS and LGS.

#### VI. Additional Information

## Actions Taken Based Upon Unconfirmed On-site Screening

PECO Energy has decided to temporarily suspend access for individuals as permitted by 10CFR26.24(d).

During the previous 6-month reporting period, (i.e., July - December 1994), 100% of the specimens which were determined to be presumptively positive for cocaine as a result of preliminary on-site screening tests were subsequently reported as positive by the HHS-certified laboratory. The confirmation rate for marijuana was less than the required 85 percent; therefore, no action was taken on specimens identified as presumptive positive for marijuana.

During this reporting period there were two specimens which were identified as presumptive positive for marijuana as a result of on-site screening. Laboratory screening resulted in one of those specimens screening positive. The specimen was also confirmed positive by the HHS-certified laboratory. The Medical Review Officer (MRO) verified that specimen as positive following discussion with the individual. Administrative actions were not taken until after the MRO determinations and only against the individual with the confirmed positive test.

#### Reduced Marijuana Cut-off Level

During the period, there was one confirmed positive test for marijuana at PBAPS. The specimen would not have tested positive using the 100 ng/ml immunoassay cut-off level.

- z. May 23, 1995 Contractor employee tested for cause based upon developed investigative information. Results: Positive for illegal drug. <u>Contractor employee</u> <u>denied access</u>.
- aa. June 1, 1995 General team sweep of construction area within the Administration Building. Results: Ten activations. No drugs found or forensic samples taken.
- bb. June 1, 1995 For cause team sweep of a contractor's private vehicle. Results: Four activations. No drugs found or forensic samples taken.

#### II. Management Actions

During the period, twenty contractor employees (i.e., sixteen pre-access, four observed behavior) tested positive at LGS. Unescorted access was denied for all twenty contractor employees.

#### III. Events Reported Under 10 CFR 26.73

During the period there was one significant FFD event reported by telephone under 10CFR26.73 by LGS.

The report contained information developed during an investigation regarding allegations and admissions of three supervisory personnel being involved in the off-site use and possession of a controlled substance. The supervisors involved were denied access to PECO Energy nuclear facilities and records documented as such for employment inquiries from other nuclear licensees subject to 91-03 data transfer. Two of the supervisors subsequently resigned from employment, the third was discharged.

Non-supervisory personnel identified during the course of this investigation who did not resign were referred to the Employee Assistance Program for treatment. Following satisfactory completion of treatment, the employees unescorted access was reinstated.

The investigation also identified two non-supervisory contractor personnel who were involved in off-site drug use. The contractor personnel were denied access. The denial of access was communicated by telephone to the nuclear licensees where the contractor personnel were then working.

All personnel identified during the investigation submitted to for cause drug and alcohol testing. None tested positive.

#### IV. Audits/Inspections

The NRC Region I conducted a reactive FFD inspection, as documented in Inspection Report Nos. 50-352/95-08 and 50-353/95-08, in response to the significant FFD event reported above. The inspection was primarily conducted at LGS, but examined aspects of the program across the Nuclear Group.

The inspection identified that PECO Energy had in place a FFD program which continued to be implemented for the protection of the public health and safety. The report commended PECO Energy's afforts in identifying the noncompliance of certain employees with the FFD program, and for taking prompt, appropriate action. The inspector reported an "apparent" violation in that supervisors with behavioral observation responsibilities failed to require for cause testing of individuals following observed behavior indicating substance abuse.

The report identified issues involving implementation of program changes, documentation of procedures for the notification of personnel selected for testing, and individuals excused from testing.

The issues have been reviewed and corrective actions are in progress.

#### V. Random Testing Rate

PECO Energy maintains separate testing "pools" for employees and contractors. Random testing is conducted at an annualized rate of 50%. The "average number with unescorted access" includes personnel granted unescorted access at both PBAPS and LGS.

#### VI. Additional Information

#### Actions Taken Based Upon Unconfirmed On-site Screening

PECO Energy has decided to temporarily suspend access for individuals as permitted by 10CFR26.24(d).

During the previous 6-month reporting period, (i.e., July - December 1994), 100% of the specimens which were determined to be presumptively positive for cocaine as a result of preliminary on-site screening tests were subsequently reported as positive by the HHS-certified laboratory. The confirmation rate for marijuana was less than the required 85 percent; therefore, no action was taken on specimens identified as presumptive positive for marijuana.

During this reporting period there were four specimens identified as presumptive positive for cocaine as a result of on-site screening. The four specimens were also screened positive and reported as confirmed positive by the HHS-certified laboratory. The Medical Review Officer (MRO) verified the four specimens as positive following discussion with the individuals. Three of the specimens were collected as part of pre-access testing; therefore, the temporary suspension of access was not applicable. The fourth specimen was collected based upon a for cause event and the individual's unescorted access was temporarily suspended. Upon MRO verification, unescorted access was denied.

During this reporting period there were eighteen specimens identified as presumptive positive for marijuana as a result of on-site screening. Eleven of those specimens screened positive and ten were reported as confirmed positive by the HHS-certified laboratory. The MRO verified the ten specimens as positive following discussion with the individuals. Administrative actions were not taken until after the MRO determinations and only against the individuals with the confirmed positive tests. (The performance data report breakdown reflects only nine marijuana positives as one individual tested positive on two specimens collected the same date.)

#### Reduced Marijuana Cut-off Level

During the period, there were nine confirmed positive tests for marijuana at LGS. Eight of the specimens would not have tested positive using the 100 ng/ml immunoassay cut-off level.
