SUBJECT: NRC INSPECTION REPORT NO. 50-498/91-30; 50-499/91-30 (NOTICE OF VIOLATION)

This refers to the inspection conducted by Mr. J. I. Tapla and other members of this office during the period November 16 through December 20, 1991. The inspection included a review of activities authorized for your South Texas Project, Units 1 and 2. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations of activities in progress.

On the basis of the results of this inspection, certain of your activities were in violation of NRC requirements. A failure to follow procedures during local leak rate testing was a contributing cause of the failure of a reactor coolant pump motor lower radial bearing. Although the actions you have taken to minimize events and problems caused by procedural noncompliance and inattention to detail have been partially effective, this violation is of concern because it indicates a need for further improvement in the area of procedural adherence during the performance of safety-related activities.

During this inspection period, several emergency diesel generator (EDG) problems were identified. EDG fuel oil subsystem problems noted during this and previous inspection periods are currently being assessed by your staff and the Cooper-Bessemer Owners' Group. In addition, a crack on a 30-inch essential cooling water system outlet pipe was identified. Your staff has determined that the crack was related to a weld repair of a previous through-wall crack that was caused by dealloying of the weld filler metal and a pre-existing defect. A management meeting, requested by NRC, is scheduled for

March 13, 1992, in order to discuss your current and planned actions to resolve EDG fuel oil subsystem problems and essential cooling water system dealloying.
