SUBJECT: FARLEY EMERGENCY PLAN REVIEW, REVISIONS 20, 21, 22, AND 23 DOCKET NOS. 50-348 AND 50-364

I. BACKGROUND

By letter, the licensee submitted changes incorporated as Revision 20 (dated October 7, 1991), Revision 21 (dated November 28, 1991), Revision 22 (dated November 27, 1991), and Revision 23 (dated December 23, 1991). Each of the aforementioned change packages were primarily related to administrative changes that resulted from the incorporation of the Southern Nuclear Operating Company (SNC). Examples of changes in this category were:

- Sections of the Plan containing references to Alabam Power Company (APCo) Nuclear Generation Department were changed to the SNC.
- Various figures and organization charts were revised to reflect changes in titles and reporting chain.
- Editorial changes made to provide clarification and legibility in certain sections of the Plan.

The above referenced changes were considered merely Plan updates that neither increase nor decrease the effectiveness of the Plan and will not be further discussed. The more substantive changes are discussed below.

- II. DISCUSSION
 - A. Revision 20

Page 80-81, Section IV.C.2. Offsite Protective Action

Section entitled "Protective Action to be Recommended to State Authorities" was revised to reflect PARs based on plant conditions (page 80) or projected dose (page 81). Previously, PARs were all consolidated and not separated out as a function of either plant conditions or dose projections.

<u>Comment</u>: This change is considered a Plan improvement that continues to meet the intent of federal guidance in the area of protective actions following a severe reactor accident.

Revision 21 B. .

Part II, Radiation Emr gency Medical Plan

Figures 5 (page 7) and 8 (page 17) were updated to reflect the relocation of the radiation decontamination receiving area. Additionally, Appendix C was updated to reflect an April 1991 Radiation Accident Plan for Southeast Alabama Medical Center (SAMC).

Comment: The aforementioned changes were merely Plan updates that neither increase or decrease the effectiveness of the Plan.

Revision 22 С.

> There were no substantive changes. All changes were administrative and considered Plan updates.

Revision 23 D.

Page 106, Section VIII. B.2.c. Emergency Communication Staff

This section previously entitled "Corporate Communication Department Personnel" received major grammatical and editorial changes. Of importance was the reassignment of responsibility for coordinating annual training for the emergency communication organization. As a result of organizational changes, responsibility was reassigned from the Director - Corporate Communication to the Manager of Public Affairs.

III. SUMMARY

Based on the review of the above changes (Revisions 20 thru 23) to the Farley Emergency Plan, the reviewer has determined that with the exception of the updates, the Farley Plan is essentially unchanged and cortinues to meet the provisions of 10 CFR 50.54(q), 10 CFR 50.47(b), 10 CFR 50, Appendix E, and NUREG-0654.

If you concur on this matter, the letter to the licensee will reflect NRC approval.
