Dear Mr. Kovach:

This acknowledges receipt of your letter dated January 10, 1992, which transmitted a change identified as Revision 34 to the Byron Nuclear Power Station Security Plan submitted under the provisions of 10 CFR 50.54(p).

We have reviewed the submitted change and have determined that it is not consistent with the provisions of 10 CFR 50.54(p). Under the provisions of 10 CFR 50.54(p), the previously approved plan revision must be followed. The item determined to be unacceptable has been discussed with NRC Headquarters (NRR/RSGB).

You are requested to provide a correction to your security plan to address the issue identified in the enclosure within two months after receipt of this letter. You may submit the change either in accordance with 10 CFR 50.54(p) or 10 CFR 50.90.

The enclosure to this letter concerns a subject matter which is exempt from disclosure according to Part 73, Title 10, Code of Federal Regulations, Section 73.21(c)(2). Consequently, the enclosure to this letter will not be placed in the NRC Public Document Room. The enclosure to your letter also contained Safeguards Information of a type specified in 10 CFR 73.21 and is being withheld from public disclosure.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter, excluding the enclosure, will be placed in the NRC Public Document Room.
