In accordance with the provisions of 10 CFR Parts 50.59 and 50.90, we are enclosing 40 copies of a requested amendment to license DPR-68 to change the technical specifications of Browns Ferry Nuclear Plant unit 3 (enclosure 1). The enclosed specifications withdraw certain revisions to the technical specifications submitted by my letter to you dated January 23, 1984 (TVA BFNP TS 195). The technical specification pages provided as enclosure 1 are to replace those submitted by the original TS 195.

Several pages submitted by the original TS 195 are to be withdrawn from review. A list of the appropriate page numbers and an explanation are provided in enclosure 2. Description and justification for the technical specification revisions is provided as enclosure 3.

These proposed technical specifications are being reviewed concurrently by the TVA Nuclear Safety Review Board for Browns Ferry.

Class III fees of \$4,000 was wired to the NRC as stated in my letter to you dated January 23, 1984. By my letter to W. O. Miller dated March 30, 1984, an additional \$8,300 was to be wired in response to NRC's fee determination of TS 195 being a Class IV, reference, NRC letter from R. M. Diggs to H. G. Parris dated March 23, 1984. No additional fees are required for this supplement.
