Subject: NRC:RI Inspection 50-317/84-01, 50-318/84-01

This transmits the January 1 - February 14, 1984, resident inspection findings by Messrs. R. Architzel and D. Trimble at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. Those findings were based on observation of activities, interviews, independent measurements, and document reviews, and have been discussed with Mr. Russell of your staff.

An apparent violation of NRC requirements is cited in Appendix A and categorized under the NRC Enforcement Policy, 10CFR 2 Appendix C (47FR9987, March 9, 1982). A reply is required in accordance with Appendix A. The requirement that you reply is exempt from clearance by the Office of Management and Budget under the Paperwork Reduction Act of 1980, PL 96-511.

In addition, this inspection identified an apparent violation of a Technical Specification LCO associated with the inoperability of an ECCS (Emergency Core Cooling System) Pump Room ventilation exhaust damper.

This item was classified as an unresolved item as defined in Chapter 0610 of the I&E Manual pending review of your event report and further NRC inspection. The event was re-examined during the February 15 - March 13, 1984 inspection period (Inspection Report 317/84-03, 318/84-03 dated March 26, 1984, Section 6.b) and determination to be a licensee identified violation meeting the criteria specified in Section IV A, Appendix C, 10 CFR 2. Therefore, a Notice of Violation was not issued.

In accordance with 10CFR2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter and submit written application to withhold information contained therein within 25 days of the date of this letter. Such application must comply with 2.790(b)(1).
