SUBJECT: SUMMARY OF PUBLIC SALP MEETING AND CORRECTION OF SALP REPORT
(50-298/95-99)

This refers to the public meeting to discuss the Systematic Assessment of Licensee Performance (SALP) report held at the Cooper Nuclear Station on August 18, 1995. The meeting was held to discuss the results of licensee performance, as documented in NRC Inspection Report 50-298/95-99, in a public forum.

The meeting was conducted as an integral part of the SALP process, as described in NRC Management Directive 8.6, "Systematic Assessment of Licensee Performance," and it provided for a candid discussion of issues related to licensee performance.

As a result of the SALP meeting discussions, one area of the report was identified as requiring clarification. The report stated that operations personnel failed to initiate corrective actions after it was identified that preconditioning concerns existed with sequencing of high pressure coolant injection and reactor core isolation cooling systems surveillance tests. The report has been revised to reflect that the vulnerability was identified by station personnel and actions were taken to document the concern, but that the formal corrective actions process was not initiated. The corrected SALP report pages are provided as an enclosure to this document. Please replace pages 4 and 5 of the SALP report (50-298/95-99) with the enclosed pages 4 and 5.


