SUBJECT: NRC INSPECTION REPORT NO. 50-416/95-12

This refers to the inspection conducted on July 9 - August 12, 1995. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Within the scope of the inspection, violations or deviations were not identified. The reactor scram recovery of July 12, 1995, was complicated by several previously known equipment problems. The lack of adequate equipment problems identification prevented effective corrective actions.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.


